## Business Credit Application

Company acknowledges that the information provided by the Customer is true and accurate. The undersigned individual(s) warrants that he or she is authorized to execute this application. This signature serves as authorization to receive personal and company credit information necessary to process this application, which may include but, not limited to; commercial & personal credits reports, bank & trade references. Company agrees to pay all costs incurred by TSC Apparel, LLC in collecting past due balances, including reasonable attorney's fees, finance charges, and NSF check fees. The attached financial statements reflect the most current financial status of the company and there have been no materials changes since that time. This financial information will remain private and confidential. No information regarding this confidential information will be released to any 3<sup>rd</sup> parties without the Customer's expressed written permission.

This AGREEMENT is between Profill Holdings DBA TSC Apparel, herein called "Company") and Customer named below. In consideration of the extension of COD or open terms by Company, Customer hereby promises and agrees as follows:

1. All orders are subject to acceptance by Company as its main office or at an authorized warehouse. Title to goods will pass to Customer upon delivery to a carrier at an authorized shipping point. Specifications and prices are subject to change without notice.
2. Any terms of sale which may be printed on Customer's purchase order forms are not agreed to and shall not apply. In accepting orders and making deliveries thereon the terms of sale shall be governed solely by the provisions stated on Company's current invoice form. All terms of sale are as stated on each invoice. Customer agrees to pay late charges of 1.5% per month (or the highest rate allowed by law) which will be charged on all past due invoices. Shipping terms are FOB ORIGIN.
3. Company reserves the right, with or without notice to Customer, to terminate extension of credit at any time. Such termination shall not affect Customer's obligation to pay the amount owing at the time of such termination or Customer's obligation to pay late charges which may continue to accrue after such termination. Payment may not be made by returning merchandise without prior express written authorization by an authorized representative of Company.
4. Customer agrees at any time to furnish, or cause to be furnished, such financial information as Company may request on its/his/her financial condition and/or the financial condition of any guarantors. Customer further authorizes Company to investigate Customer's corporate and guarantors' bank, commercial and consumer credit history and hereby authorizes and requests all references to release information to Company.
5. Customer agrees to pay reasonable attorney's fees and court costs as determined by the court should Company initiate litigation and (or) collection action to recover monies (i/e; attorney's fee's, collection cost & fee's, finance charges, and NSF check fees) owing by Customer. This Agreement shall also bind the heirs, personal representatives, successors, and assigns of all the Companies & Customer signing below. An executed faxed and/ or facsimile copy of this agreement will be binding and will be admissible evidence in lieu of an original signature copy. This AGREEMENT shall be deemed to be made under the laws of the State of Ohio and shall for all purposes be construed and enforced in accordance with Ohio Law.
